- Master's degree or higher
- At least five years of professional experience in an international context
- Teaching experience at bachelor/master/executive education level
- C2 proficiency in English

- Latest market developments of sustainable finance (incl. on the green and SLB bond segments)
- EU Sustainable Finance legislative pieces and proposals (e.g. Taxonomy Regulation, EU Green Bonds Standard, SFDR, CSRD, ESG and climate benchmarks)
- ESG metrics and indicators
- Climate-related Financial Risk Analysis
- Climate risk scenario design and stress testing

- Integration of Climate-Related Risk Factors/Metrics into Risk Management Approach
- ESG risks and internal governance of financial institutions
