LIVE CLASSES

EXERCISES

- A self-paced part, where you will answer a quiz on the basis of mini-case studies.
- A group activity, where you will work alongside a group in answering a set of questions.
- Exercises have precise deadlines so be mindful of the timing.
- You will find all information necessary to complete the exercises on the course platform.
