LIVE CLASSES

Although it can be a useful tool to catch up if you have missed the Live Class, please be mindful that it does not constitute a substitution of your attendance in the Live session. Therefore, if you miss a Live Class, you will be counted as absent.

For the Live Classes, you might be asked to read and prepare **some mandatory readings ahead of the live classes** in order to enhance the discussion during the Live Sessions.
